SUBJECT: Title V of Stewart B. McKinney Homeless Assistance Act (McKinney Act),  
Implementation Instructions

1. The purpose of this memorandum is to provide instructions to simplify compliance with Title V of the McKinney Act (42 U.S.C. § 11411 - 11412). Currently, McKinney Act federal screening requirements are scattered across several Army Regulations, DA PAM, an Executive Order and several different parts of the Code of Federal Regulations. The consolidation of these various documents provides all the necessary instructions regarding the screening of federal property, as required by the McKinney Act, to enable installation personnel to more easily complete the necessary documentation required by that Act.

2. Congress enacted the Stewart B. McKinney Homeless Assistance Act (Public Law 100-77) on 22 July 1987. The intent of the McKinney Act is "to use public resources and programs in a more coordinated manner to meet the public resources and programs in a more coordinated manner to the critically urgent needs of the homeless."

3. Title V of the McKinney Act requires the US Department of Housing and Urban Development (HUD) to request information from federal landholding agencies regarding unutilized, underutilized, excess, and surplus federal real properties (including land, buildings, and fixtures). Pursuant to the McKinney Act, HUD must collect this information on a quarterly basis in order to determine which properties may be suitable for use as facilities to assist the homeless. HUD has the sole responsibility for determining whether a property is suitable for use by the homeless.
